1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of "Energy Dues". Complainant, pleading that OP has wrongly concluded that there are dues at property & connection already exists. He prayed this Forum for grant of his complaint by issuing directions to the respondent to examine the property and allow his application for new connection.

- 2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. I-15 G/F, Shop No. 02 Block-1, Subhash Chowk, Laxmi Nagar Delhi-110092 vide request no. 8006125015 but respondent rejected his application for new connection on the pretext of Energy Dues on property and connection already exists. Therefore, complainant's application for release of new connection may be granted.
- 3. OP in its reply briefly submitted that the complainant applied for fresh electricity connection at premises no. I-15 G/F, Shop No. 02 Block-1, Subhash Chowk, Laxmi Nagar Delhi-110092 vide request no. 8006125015. The complainant placed on record Sale Deed dated 08.02.2023 which is executed by Sh. Sudhir Kapoor S/o Ashok Kapoor in favor of complainant in respect of Shop no-2. Shop no. 1 and 2 already had one electricity connection exists in the name of Ms. Shanti Devi bearing CA no. 152159426 which was energized on 11.05.2017. As the said shops bearing nos 1 and 2 which is owned by single person is already electrified, no new connection can be granted.
- 4. Case was put up for hearing on 05.04.2023, when representative of the complainant was present and submitted withdrawal letter stating therein that he wishes to withdraw his complaint.
- 5. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
- No order as to the cost. Both the parties should be informed accordingly. File be consigned to Record Room.
