- 2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. 28900, 4th floor, Chuna Mandi, Pahar Ganj, Delhi-55 vide application no. 8006129075 but respondent rejected his application for new connection on the pretext of pending dues and meter already exists at applied premise. Therefore, complainant's application for release of new connection may be granted.
- 3. Case was put up for hearing on 10.03.2023, when none was present on behalf of the complainant and complainant vide his letter dated 24.02.2023 informed the Forum that his grievance has been redressed and he wishes to withdraw his complaint.
- 4. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
