1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the Complainant, pleading that pretext of same site energy dues. respondent has wrongly concluded that his energy dues pertains to his premsies, has prayed this Forum for grant of his complaint by issuing directions to the respondent to allow his applications for new & & 4 connection.

- 2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. S-609 A, Nehru Enclave, School Block, Shakarpur, Delhi-110092 vide application no. 8005994349, 8005994316 and 8005994372 but respondent rejected his application for new connections on the pretext of same site energy dues. Therefore, complainant's application for release of new connection may be granted.
- 3. OP in its reply briefly stated that complainant applied for new electricity connection vide application no 8005994349, 8005994316 and 8005994372 at premises bearing no. S-609-A, Second Floor, Nehru Enclave, School Block, Shakarpur, Delhi-110092.

OP further added that Ms. Noor Bano and Ms. Sazia Parveen were the owners of subject property which they had purchased from Sh. Vijay Singh Bothra in January 2012. One connection in the name of Vijay Singh Bothra was already installed vide CA No. 100950916 in the subjected premises and the connection was disconnected on 16.11.2014. In the meantime Noor Bano took one connection in her name baring CA No. 151481777 which was disconnected in year 2016 on account of outstanding dues. The dues were transferred to CA No. 151598705. This connection was also disconnected on outstanding dues of Rs. 105520/-which were equally transferred to live connections having CA No. 152950672 (Swami Nath) and 152655496 (Vivek Kumar) on 31.12.2021.

Mr. Swami Nath had paid the outstanding dues amounting to Rs. 49,215/- on 06.09.2022. The complainant purchased the property on 22.10.2022 from Noor Bano and as such on pro-rata basis he is liable to clear all the outstanding dues related to the property.

- 4. Case was put up for hearing on 02.02.2023, when none was present on behalf of the complainant but the representative of the complainant through mail submitted withdrawal letter stating therein that his case has been resolved, therefore he wishes to withdraw his complaint.
- 5. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
- 6. No order as to the cost. Both the parties should be informed accordingly. File be consigned to Record Room.
