# Order Pronounced By:- Mr. S.R. Khan, Member (Technical)

1. The brief facts of the case giving rise to this grievance are that complainant Ms. Kamlesh, applied for new connection vide application no. 8006155576 at premises no. A-29, GF, Kh. No. 25/5/1, Gali No. 1, Phase-1, Shiv Vihar, Karawal Nagar, Delhi-94, but respondent rejected her application for new connection on the pretext of removal of existing meter required. Therefore, her application for new connection may be granted.

### Complaint No. 201/2023

 OP in its reply briefly submitted that complainant is seeking new temporary electricity connection at ground floor of property bearing no. A-29, Kh. No. 25/5/1, Gali No. 1, Phase-I, Shiv Vihar, Karawal Nagar, Delhi for the purpose of construction.

As premises are already electrified through CA no. 153238238 and as there was property dispute in respect whereof dispute DP was also created as such application of complainant was rejected.

After the issuance of deficiency letter complainant got the existing meter removed but the dispute DP still exists. The property dispute is between one Kuwar Pal Singh and the complainant.

- 3. Case was put up for hearing before the Forum on 03.08.2023, when counsel of the complainant submitted withdrawal letter, stating therein that the complainant wishes to withdraw her compliant. Forum kindly grant the withdrawal.
- 4. In view of the above, withdrawal is allowed. The case is dismissed.
- No order as to the cost. Both the parties should be informed accordingly. File be consigned to Record Room.
