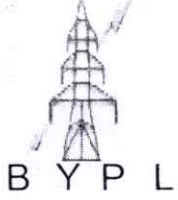

1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of "MCD objection". Complainant, pleading that respondent has not released new electricity connection with the reason that his premises exists in MCD objection list, but complainant alleged that the said reason is absolutely wrong. Therefore he prayed this Forum for grant of his complaint by issuing directions to the respondent to allow

2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. 6, GF, Kh. No. 25, Radha Vihar, New Mandoli Industrial Area, Delhi-93, vide Request no. 8006192058 but respondent rejected his applications for new connection on the pretext of Premises booked by MCD. Therefore, complainant's application for release of new connection may be granted.
3. OP in its reply briefly submitted that the complainant applied for fresh electricity connection at premises no. 6, Khasra No. 25, Radha Vihar, New Mandoli Industrial Area, Delhi-110093, vide Request no. 8006192058 and on verification it was found that one non-domestic connection already exists at ground floor having meter no. 35786285. The said connection is granted for godown purpose for 100 sq yards. The complainant wants second connection in respect of ground floor which is of 100 sq yards and is already electrified.
4. Case was put up for hearing on 23.05.2023, when representative of the complainant was present and submitted withdrawal letter stating therein that he wishes to withdraw his complaint.
5. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
6. No order as to the cost. Both the parties should be informed accordingly. File be consigned to Record Room.
