1. The brief facts of the case giving rise to this grievance are that complainant Mr. Mayank Aggarwal, is using electricity through CA No. 153000438 released on 14.12.2019 and at the time of release of new connection no dues were pending against the complainant. It is also his submission that OP transferred dues of other disconnected connection having CA No. 100620315 to his live connection. Therefore, he requested the Forum to direct the respondent for wavier off transferred dues as the same does not pertain to him.

## Complaint No. 22/2023

2. OP in its reply briefly submitted that this complaint is regarding premises no. W-57, GF, GaliNo. 10, Main Road, Kedarnath Marg, Anand Parbat Industrial Area, Delhi. On 13.04.2022, outstanding dues of Rs. 78807.62/- transferred from CA No. 100620315 (Mayank Kumar) to CA No. 13000438 (expo engineer works). The live electricity connection in name of Expo Engineer Works has billing address W-57, c/o Mayank Aggarwal, GF, Gali No. 10, Main Road, Kedarnath Marg, Anand Parbat Industrial Area, Delhi Near Bodh Mandir.

OP further added that disconnected connection is in the name of Mayank Kumar S/o Arun Kumar, CNW-57, Rai Kedarnath Marg, Main Road, Gali No. 10, Anand Parbat Industrial Area, Delhi Near Ram Dharam Kanta. As outstanding dues pertains to complainant premises as such after inspecting the premises on 27.11.2021 and after issuing show cause notice to the complainant on 30.11.2021 dues were transferred as per law on 13.04.2022.

- 3. Case was put up for hearing on final hearing on 15.06.2023, when representative of the complainant submitted withdrawal letter stating therein that his grievance has been redressed and OP has revised the bill, thus, he wishes to withdraw his complaint.
- 4. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
- 5. No order as to the cost. Both the parties should be informed accordingly. File be consigned to Record Room.
