The complainant in his complaint submitted that he applied for new electricity connection at premises no. 4/203, SF, Lalita Park, Laxmi Nagar, Delhi-92 vide application no. 8006125367 but respondent rejected his application for new connection on the pretext of address in MCD objection list, completion and occupancy certificate required. Therefore, complainant's application for release of new connection may be granted.
- 3. Case was put up for hearing on 10.03.2023, when representative of the complainant and complainant vide his letter dated 23.02.2023 informed the Forum that he wishes to withdraw his complaint.
- 4. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
- 5. No order as to the cost. Both the parties should be informed accordingly. File be consigned to Record Room.
