1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of "MCD objection". Complainant, pleading that respondent has not released new electricity connection with the reason that his premises exists in MCD objection list, but complainant alleged that the said reason

is absolutely wrong. Therefore he prayed this Forum for grant of his complaint by issuing directions to the respondent to allow,

- 2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. 201/2, 3rd floor, second floor and UG floor, Moti Ram Road Nagar, Shahdara, Near Mandir, Delhi-32, vide Request no. 8006222316, 8006222402 and 8006221082 but respondent rejected his applications for new connection on the pretext of Premises booked by MCD. Therefore, complainant's application for release of new connection may be granted.
- 3. OP in its reply briefly submitted that the complainant applied for fresh electricity connection at premises no. 201/2, Moti Ram Road, Ram Nagar, Shahdara, Near Mandir, Delhi-32, and on verification it was found that property was found adjacent to property bearing no. 600 and opposite property bearing no. 601. The property bearing no. 600was found in various MCD objection lists forwarded to respondent including list no. EE(B)-II/SH-N/2018/D-1064 and EE(B)-II/SH_N/2019/D-459 dated 27.07.2018 and 22.05.2019 respectively. The subject property is mentioned at serial no. 62 and 95 respectively. As per second list unauthorized construction is in the shape of GF + erection above with projection.
- 4. Case was put up for hearing on 22.06.2023, when representative of the OP was present and submitted withdrawal letter stating therein that the wishes to withdraw his complaint.
