### **ORDER**

1. As per complaint, the complainant is using electricity through CA No. 153892408, installed at his premises no. 520/12, Plot no. 12, Second floor, Industrial Area, Dilshad Garden, Delhi-110095. He further submitted that his supply was disconnected the connection without giving any reason or disconnection notice.

2. OP in its reply briefly submitted that the complainant is seeking restoration of connection bearing CA No. 153895889 which was installed at second floor of premises no. 520/12, Industrial Area, Dilshad Garden, Delhi-95 and the said connection was disconnected in MCD sealing drive on 30.09.2022. MCD issued letter dated 09.09.2022 to Deputy Commissioner of Police, District Shahdara for requisition of police force for special demolition/sealing action program against unauthorized construction at properties no. 520/1 & 2, 520/5, 520/6, 520/7, 520/10 and 520/12, Mahalaxmi and Ganpati Compound, GT Road, Dilshad Garden, Delhi and copy of said letter was also marked to respondent for disconnection of electricity connections as may be found existing in said properties. OP further added that said operation took place on 30.09.2022, thus the connection of the complainant cannot be restored till the premises are de-sealed and communication is received from MCD to reenergize the electricity connection.
3. Representative of the complainant rebutted the contentions of respondent as averred in their reply and submitted that this Forum has already released the connection in the subjected property in the matter of Rohit Bansal C.G. No. 219/2022. He also submitted that his connection having CA no. 153895889 sanctioned load 11 KW SIP installed on 26.08.2022. OP raised bill and same was paid by the complainant on 04.10.2022.
4. LR of the OP submitted that the supply was disconnected by O&M on the basis of letter no. EE(B)-I/SH-N/2022/D-268 dated 09.09.2022 under sealing action against un-authorized construction in properties no. 520/1 & 2, 520/5, 520/6, 520/7, 520/10 and 520/12, Mahalaxmi and Ganpati Compound, GT Road, Dilshad Garden, Delhi. Due to resistance at site the supply was disconnected from pole. Later, the meters were also removed from site.

5. Heard both the parties and perused the record. From the perusal of evidence placed on record pleadings and after hearing both the parties it is evident that the supply of the complainant was disconnected during the sealing drive vide order no. EE(B)-1/SH-N/2022/D-268 dated 09.09.2022 for unauthorized construction under the jurisdiction of GTB Enclave police station, copy of same was also marked to the CEO (BYPL) to disconnect the electricity supply. Also, regarding the connection released in property no. 520/1 & 2 in the matter of Rohit Bansal, C.G. No. 219/2022 vide order dated 09.01.2023 of the Forum, the said connection was released as the respondent filed MCD objection list of the year 2018 and 2020. No letter of MCD dated 09.09.2022 was placed on record by the respondent. The complainant placed on record NOC of EDMC vide no. EE(B)-1/SH-N/2020/D-111 dated 18.09.2020 which clearly stated that property bearing no. 520/1 & 2, Mahalaxmi Compound, Dilshad Garden, Delhi in the name of Sh. Rohit Bansal is not booked under unauthorized construction. The facts presented before the Forum of both the cases are entirely different therefore; the Forum has ordered to release the connection in the matter of Rohit Bansal C.G. No. 219/2022.
6. In view of the above, we are of the considered opinion that the premises of the complainant is sealed by MCD for unauthorized construction, therefore, respondent has rightly rejected the application of complainant for restoration of supply.


ORDER
