## Order Pronounced By:- Mr. P.K. Agrawal, Member (Legal)

1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of pole encroachment. Complainant, pleading that respondent has wrongly concluded that there is improper clearance from pole, has prayed this Forum for grant of his complaint by issuing directions to the respondent to allow his application for new connection.

- 2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. E-4/345, SF, E-4 block, Nand Nagri, Delhi-93, vide application no. 8006085366, 8006084086, 8006085267 and 8006084134 but respondent rejected his application for new connection on the pretext of pole encroachment. Therefore, complainant's application for release of new connection may be granted.
- 3. Case was put up for hearing on 16.03.2023, when none was present on behalf of the complainant and complainant vide his letter dated 07.03.2023 informed the Forum that his grievance has been redressed and he wishes to withdraw his complaint.
- 4. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
- No order as to the cost. Both the parties should be informed accordingly.
